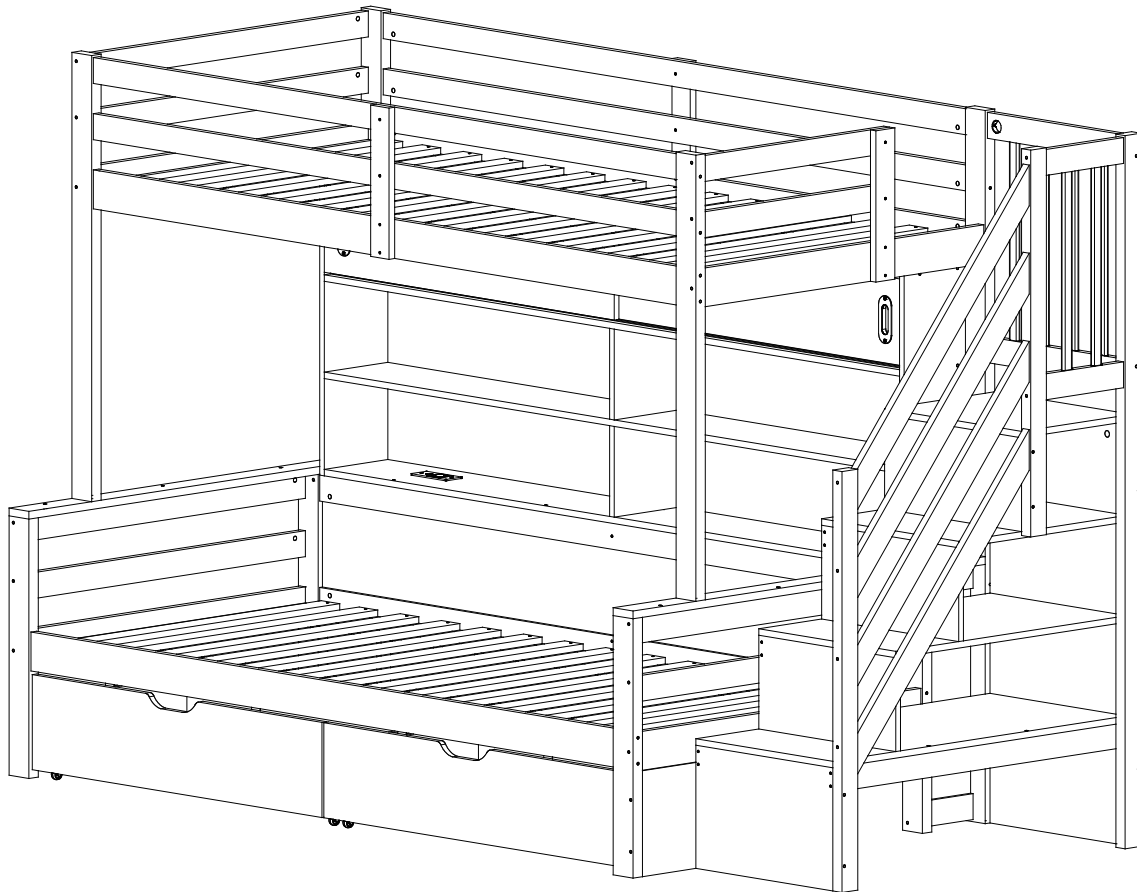

JÖVŐBEN

- a) **VIGYÁZAT** - A magas ágyak és az emeletes ágyak felső ágya nem alkalmas hat év alatti gyermekek számára az esések sérülésének veszélye miatt;
- b) **FIGYELMEZTETÉS** - Az emeletes ágyak és a magas ágyak súlyos sérülést okozhatnak a fojtogatás következtében, ha nem használják helyesen.
